# SEXUAL VIOLENCE AGAINST CHILDREN

**Sexual violence affects millions around the world, and children in poor countries are some of the most vulnerable.**

They are at risk in their homes, schools and in their communities. But, with no money for a lawyer, it's harder for impoverished children and their families to get justice.

In many places, there is no meaningful justice system response to sexual violence against children. Police are often untrained on investigations, and courts don't protect children during the intense trial process. As a result, rapists know they can target children without fear of the law.

## QUICK FACTS

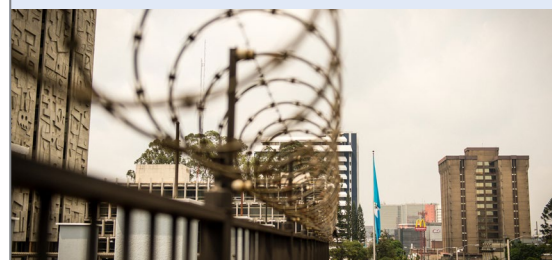


An estimated **1 in 5 women** will be a victim of rape or attempted rape in her lifetime.<sup>1</sup>

**Basic daily activities**—like collecting water—can put girls and women at particular risk of sexual assault.<sup>2</sup>



For many poor girls, **school is the most common place** where sexual violence occurs.<sup>3</sup>



## GUATEMALA JUSTICE SYSTEM PERFORMANCE STUDY, 2013

Justice is out of reach for the vast majority of sexual assault victims in Guatemala. IJM's comprehensive review of reports of sexual violence made to Guatemalan authorities between 2008 and 2012 found that **94% had not reached a verdict.**

## Meet Griselda\*

**OUT OF NOWHERE**, three men grabbed 13-year-old Griselda off the street, held her at gunpoint and violently assaulted her. Police found her just in time, but the terrifying assault left her paralyzed with fear for months. She avoided all men, and her family was devastated by the pain she was facing. “I felt very lonely,” she remembers, “dare I say it—filthy, guilty for what happened to me.”

Many families in Guatemala do not report sexual assaults because they fear retaliation from the perpetrator. But Griselda’s parents knew they had to try to get justice. “Otherwise,” her mother said, “there will be more little girls who will be harmed.”

Griselda’s family came to IJM for help. Our lawyers built a strong legal case, and social workers helped Griselda overcome her fear and shame. Her mother says tearfully, “IJM stood with us in every moment. We were never alone.” With Griselda’s brave testimony in court, all three men were eventually found guilty.
